A. CHANGE OR ADVANCMENT OF GROUP'S FOCUS/GOALS

1. How is your project progressing? Briefly describe its evolution.

The Sheridan Street Green Block has engaged more than a quarter of the roughly 200 households in the 3-street area; activists on the block are having regular meetings every month or two, setting up a leadership committee, set up a listserv to enhance communication, and developed a book group.

The Gayhead Green Block has engaged about half the 50 households on the street. Active members are meeting monthly and planning a big gardening and communal food prep campaign. BostonCAN is assisting them in submitting a funding proposal to NEGEF for this purpose.

The Paul Gore Green Block has hosted a Smart Energy Party and has begun a Low Carbon Living group. Active members have convinced the City of Boston to grant them usage of a raised bed near the foot of the street, which they are converting from ornamental plantings to a combination of ornamental and edible plantings. This "Festival Garden" is planned to be communally harvested, rather than individual plots.

2. What factors have helped move your project forward?

Dynamic block leaders who already know many neighbors and have the skills to engage more people.

3. What obstacles still stand between your group and achieving "success?"

Block leaders need more leadership development. Staff support is particularly important for communications, publicity, and bringing in new resources (financial, intellectual, political).

B. LEADERSHIP DEVELOPMENT

1. Have members of your group become more active in other community activities or organizations since you began your project? If so, in what ways?

Among other overlapping networks, Judy from Sheridan Street is taking an organizing course through a local CDC. Carolyn from Gayhead is coming regularly to Green Justice Coalition meetings. Jenny from Paul Gore is engaging with JP New Economy Transition.

2. Did the experience with this group make you and/or other group members more politically active at any level? If so, at what level: local, state, regional?

In addition to the Green Justice's statewide campaign, Green Block members have been active in Jamaica Plain meetings related to the replacement of a grocer that served primarily lower-income Latin American immigrants with one that is likely to serve a wealthier and less racially oppressed customers. Green Block members have also attended the neighborhood-based sustainabily networking meetings that BostonCAN has convened.

C. COMMUNITY CHANGES

1. In your opinion, have you and/or group members significantly increased their knowledge of any of the following: environmental justice, environmental health, greenspace issues, how your community works or how to solve problems locally?

Environmental justice has been a big part of our learning this year, especially through the Green Justice Coalition work. Members testified at hearings, attended rallies and strategy sessions and encorporated this perspective in our energy efficiency work. We also learned more about how the utilities and state regulators interact to shape energy efficiency policy.

2. Since the group's formation, have other local environmental issues received community attention and sparked other community activism? If so, what issues?

Peak oil is beginning to be discussed more widely. And the Transition Town model.

D. NEGEF'S IMPACT ON GROUP'S WORK

1. Although it's hard to quantify, please tell us if and how NEGEF's grant and support made a difference to your group and its work. If you had not received the grant from NEGEF, what difference, if any, would it have made to your project?

NEGEF funding gave us a foundation for being able to start to explore networking more actively with other sustainability-related neighborhood groups in the metro area. It also made a huge difference to the amount of support we could give to our Green Block volunteers.

Communications – how to more efficiently home a message and re-purpose it in the multitude of messaging platforms, traditional and virtual.

We received Stimulus Act funds via both the City of Boston and the Commonwealth, to encourage people to take advantage of Mass Save and Renew Boston; \$24,000 in total. We also rec'd \$10,000 from New World Foundation, and \$5000 from ACE for TA on an EPA carbon reduction grant.
