Job Location: Staff members work remotely across New England. Applicants should be based in New England or greater Northeast region with the ability to travel to central New England (Worcester, MA/Seacoast, NH) within a half-day's drive (transportation costs are reimbursable).

Organizational Summary: The New England Grassroots Environment Fund (Grassroots Fund) is a 501(c)(3) environmental justice funder with a mission to energize and nurture long term civic engagement in local initiatives that create and maintain healthy, just, safe and environmentally sustainable communities. Our program work:

- fosters innovation by directly providing grants to frontline environmental justice/just transition organizers and engaging in conversation around our <u>Guiding Practices</u> towards transformative work;
- shifts power in decision-making by amplifying the voices of grassroots leaders in participatory decision-making processes;
- convenes changemakers through our Community of Practice work, RootSkills Training Series, Catalyst Conversations and pop-up offices;
- reimagines philanthropy through our shared decision-making ethos, which includes working to disrupt white supremacy culture across programs and participatory grantmaking.

The Grassroots Fund co-creates healthy and sustainable communities throughout New England by providing individuals and groups - particularly those who have been traditionally marginalized - with access to the connections, resources, and tools they need to achieve environmental and social justice. Our <u>Guiding Practices</u> are fundamental to our mission, functions and programs.

The Grassroots Fund's participatory processes create many learning opportunities in the application narrative, during participatory review, and through the reporting stage. Applicant groups share how they root the work in community feedback, how they make decisions, how they lower barriers to participation and how they center Just Transition in their work. Grant review participants actively discuss and reflect on practices shared and the grant reports close the loop on how efforts are

Fostering Innovation through Grants progressing. As a learning organization, the Grassroots Fund is committed to continuously aggregating these learnings and creating the spaces - passive & interactive, virtual & in-person - to share out and collectively evolve best practices.

Position Description: The Community Organizing Strategist will expand learning around Environmental Justice practices, grassroots organizing strategies, and participatory grantmaking processes to our larger network of grant applicants, Community Grant Readers, Grantmaking Committee Members, grantees and philanthropic/non profit colleagues. This is a new position that will lead design and support of virtual and in-person gatherings, follow best practices in instructional design, and actively evaluate efforts to increase impact. The Strategist will support the implementation of data management protocols to ensure that learning is translated into active engagement with the Grassroots Fund's greater community through passive (toolkits, PDF briefings) and interactive (discussions, in-person convenings) spaces.

The Strategist works collaboratively as a team with Co-Directors and the Development Strategist and plays a coaching/support role with program staff. The Strategist promotes reflection, provides guidance and structure where needed and focuses on strengths, collaboration and common areas of improvement.

The Community Organizer's primary focus areas in support of the organization's mission include:

- Leading strategy for virtual and in-person spaces to convene grassroots organizers. Strategist works with Co-Directors to develop a data management approach that allows users to find peers based on meaningful search criteria and for those users to be aware of opportunities to convene and connect. This approach is rooted in our grant making program and requires developing an external and interactive tool that is visible and easy to use. Strategist is responsible for cultivating awareness of this tool and for creating a calendar of opportunities (taking into account other programmatic activities) for users to convene. Strategist is responsible for developing an 'event flow' and facilitation support tools for all staff to be able to support these types of gatherings
- 2. Leading strategy for virtual and in-person spaces to talk about learning (Guiding Practices). Strategist works with Co-Directors to determine delivery mechanisms to share learning (passive learning through publications and interactive learning in virtual and in-person settings). This task requires collaboration across all staff to develop relevant content through data analysis and relevant frameworks and facilitation guides for shared (differentiated) learning. This task also includes logistics of setting up learning series for users to participate in. Strategist is responsible for making final decisions on content priorities and best practices for delivery. Strategist is responsible for cultivating awareness of these offerings across all users.
- 3. Creating a comprehensive schedule of offerings, determining pacing of opportunities, and development of scaffolded resources and selection of best practices to meet the needs of participants. The Strategist oversees the implementation of events and convenings, including evaluating the effectiveness of events and convenings in meeting the organization's goals and strategies.
- 4. Facilitating external digital communications (examples including social media and email newsletters) and coordinating staff content/contributions;
- 5. Assisting with participatory grant review process for Grow grant program as needed.

As the Grassroots Fund is a small non-profit, we seek someone who can work well independently and manage multiple projects and priorities. Candidates should have a high level of comfort working with online organizing tools like Google Docs/Drive and Zoom.

A candidate needs to have the ability to travel regularly within New England - and occasionally beyond - and participate in occasional evening and weekend obligations. We are looking for someone with flexibility and creative, solution-seeking skills.
